News from the Superintendent

Greetings! As I write this letter to you it is the beginning of August but it is in great anticipation for the start of the 2019-2020 school year! As customary with a superintendency, my first year was filled with observing and learning about the district and the community. I am sure I have more to learn but I can say with confidence that I am thrilled to be a part of the SCS family. I look forward to our coming years and what we can accomplish together. There are some exciting changes for this year.

Our Universal Pre-Kindergarten Program is going to a full-day program. There are a variety of benefits that come with this change including: a more relaxed school day, more innovative curriculum, less time in large group and more time in child-initiated activities, more individualized instruction, greater creativity, greater progress in social skills, more reinforcement of positive behaviors, and higher self-esteem and independence. We have moved the PreK classroom across the hall to the largest primary classroom to accommodate space for daily rest time, while still leaving room for learning/play areas.

We are also starting to pilot 1:1 device use. Students in 9th and 10th grade will be issued small laptops that they will be able to take out of the classroom. Home internet will not be essential, as students can download items prior to leaving school as needed. Teachers will have opportunities for training to better utilize the devices for a blended learning environment. We will also have iPads located in the 2nd grade classrooms for student use.

Last year we had our first VEX robotics course for 7th graders. This year we are expanding to add an additional VEX robotics course for 8th grade students. We have secured a Small Rural Schools Achievement grant to aid in buying the equipment for these courses.

We are also looking to move forward in other areas. Our goals for this school year include expanding our mental health instruction curriculum. This instruction is state mandated but also, incredibly important. As part of our Comprehensive Counseling Plan we have set a goal to improve the resiliency

skills with a focus on our students in grades 4-6. Another goal is beginning a three-year implementation plan to improve school culture through the use of social emotional learning and restorative practices. Through the communication that will result from these practices, our learning environment will increase in mutual respect and understanding of one another.

Lastly, we have the physical changes that are happening at SCS. Some of the summer and fall highlights include the installation of the new field lighting, restroom renovations, district office renovations, new boiler installation, baseball and softball field infield improvements, lighting of our flag, new auditorium seating, finishing of the auditorium floor, new classroom door locks for added security, and locker room renovations. This has been a busy place this summer with a busy fall yet to come!

I am grateful for our summer staff who have spent their summer feeding children, providing transportation and preparing our school for another great year! I look forward to working with families again and having your children and the instructional staff back in the building soon!

Fire Prevention Week 2019

National Fire Prevention Week this year runs Monday, October 7th through Friday, October 11th. As we have in the past, we will be having a fire prevention and safety program for our PK – 6 students during that week of school. This program provides information and training that the students can take with them and pass on to their family at home as well. This has always been a passionate area for our district and has offered an invaluable teaching opportunity for our staff to make a connection with our students, as well as with our community, to show how much we care about the well being of all of those who live in our district.

Because we care so much about educating our students and community about safety, we will also be having a bus safety program. This will be offered to all students in PK – 6, regardless of whether they



ride a bus regularly or not. It is extremely important for the information to be passed on to all of them because of the nature of our students becoming involved with other

school activities such as field trips, music programs, and sports as examples, which would at some time involve every one of them riding the buses.



Transportation Information

At Scio Central School, we work hard making sure necessary steps are followed to ensure the safety of all our students. We have established procedures to assist us in this goal. We encourage you to review the following information and discuss each item with your child. If you have any questions or concerns, please contact the Transportation Department at 585-593-0987.

Board of Education policy states that students in grades PK-3 will not be dropped off unless the bus driver is certain someone is there for the student. We need you to do one of the following:

- Stand in a window or doorway
- Come outside
- Stand in the driveway
- Please wave to the driver, so he

or she can see you.

If it seems that no one is available, the student will be brought back to the school and their emergency contact person will be called to pick the student up. It is our wish to avoid any inconvenience for parents. PK students need to be escorted to and from the bus stop. PK students will be seated toward the front of the bus at all times.

Make sure your child/children are at the bus stop at the appropriate time!

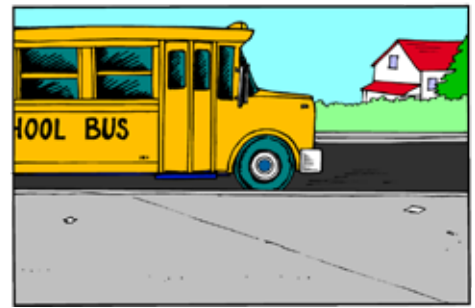
There will be three scheduled bus safety drills for all students during the school year. **Please remind your child/children of our school bus safety rules:**

- Stay seated – facing forward
- No eating or drinking
- Talk quietly using appropriate language
- No hitting, kicking or bullying
- No glass containers or aerosol spray cans of any type
- No tobacco products of any kind, including electronic devices

According to the Commissioner of Education, a school district is **NOT** responsible for transporting students to more than one location (even when that student's parents are divorced). There is no statutory or regulatory requirement which states a district must transport a student to different places on different days of the week.

Each student may have only ONE designated pick-up point and ONE designated drop-off point.

The morning pick up and afternoon drop off may be different, but they must be the same locations DAILY.



Students will NOT be transported to other students' homes, except in the event of an EMERGENCY.

In the event of an EMERGENCY or any bus change, please contact the Main Office at 585-593-5510, Ext. 1163 BEFORE 1:30 p.m. in order for the transportation department and your child's teacher to receive the notification of the change in a timely manner.

All students being dropped off at school must be dropped off in the front of the school building. Please remember there is a 5-mph speed limit on school grounds. There is always the possibility of students in the driveway or parking lot.

We thank you, in advance, for your continued support in making our school the safest it can be for our children. If we can help to clarify any items in this letter, please do not hesitate to call.

Great News, AGAIN!

Scio Central School is pleased to announce that we will continue to participate in the Breakfast and Lunch program, Community Eligibility Provision (CEP), for the 2019-2020 school year.

What does this mean for our students? Every child will receive a healthy breakfast and lunch for FREE. Yes, we mean FREE.

Applications

All families are encouraged to continue filling out the Household Income Form. The form will be sent home at the beginning of the school year, or can be picked up in the office or cafeteria. We are asking for every family to complete a form. Qualifying families will help us to continue receiving special grants and funding throughout the school district.

All information is strictly confidential.

ID Cards

All students and staff will be issued an ID card with their picture and ID bar code on it. Cards will be provided by the school when pictures are taken. Students in grade 5-12 will be able to use the finger scan system for any purchase made in the cafeteria.

Pre-Paying on Account

As both breakfast and lunch are free the only money needed will be for ala carte items, such as extra milk or a second meal. It is best to prepay on your account by giving the cashier money ahead of time. Parents may send in a check or money in an envelope or stop by the school to make a payment. All money will be added to your student's account and the cashier will access the account at the time of purchase.

Ala Carte Sales

Students desiring ala carte items, such as extra milk or a second meal must pay cash or have money in their meal account. **Students will not be allowed to charge ala carte items.**



Does the school provide a second breakfast or lunch for free?

No. The school only gets reimbursed from New York State on the first breakfast and lunch served. Families are responsible for payment of a second meal.

Can children still bring their lunch?

Yes. However, if they buy milk, it is the families' responsibility to pay for the milk.

How will ala carte items (pizza, nachos, chips, etc.) be handled?

As in the past, families will continue to pay for a la carte items. ***Available a la carte items are shown on page 11.***

Will the school district request a household application?

Yes. Other federally funded grants that the district receives are based on the district's poverty levels. This data was gathered through the cafeteria free and reduced applications process. In order to continue to receive such grants, the income information still needs to be gathered. We encourage all families to submit applications as these play a crucial role in the district maintaining these grants!

Community Eligibility Provision Program

The Scio Central School District is committed to providing every student enrolled with all the tools they need to succeed, including nutritious meals that everyone can enjoy. The Community Eligibility Provision program is offered through the New York Child Nutrition Department and allows the district to provide a free breakfast and lunch to every student!

Here are some questions and answers regarding the Community Eligibility Provision program.

How does this program work?

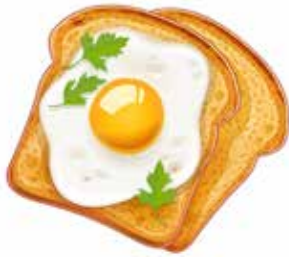
The New York State Child Nutrition (CN) Department began this program several years ago with federal funding backing the program. School districts must be eligible based on their specific

poverty rates and have to apply to CN for approval.

I am the parent/guardian of _____ [student(s) name and grade level(s)], who attend Scio Central School District. It is my understanding that a new school law may require every school on an annual basis to maintain a list of parents who wish to receive advance notice of pesticide applications at the school their child attends.
